3	Scrutiny of Nomination Forms (Venue: Mahatma Phule Hall/ Management Council Hall of the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad)	04-04-2018 (11 am onwards)	The Candidate or his authorized Representative, whose name has been included in the concerned Board of Studies having written authorization of the Candidate in this behalf shall be entitled to be present at such scrutiny.
4	Declaration of Valid and Invalid Nominations	05-04-2018 (Upto 5 pm)	After scrutiny, Lists of Valid and Invalid Nominations shall be Web published on the Election Portal of the University Website.
5	Period for "Appeal on Valid and Invalid Nominations"	06-04-2018 to 07-04-2018 (Upto 5 pm)	Appeal, if any, shall be referred to the Hon'ble Vice- Chancellor, Dr Babasaheb Ambedkar Marathwada University.
6	Declaration of Valid and Invalid Nominations (after Appeal)	09-04-2018 (Upto 5 pm)	Valid and Invalid Nominations after Appeal shall be Web published on the Election Portal of the University Website.
7	Withdrawal of the Nominations	10-04-2018 (Upto 5 pm)	The Candidate shall submit a duly signed application for withdrawal of his/ her nomination, in person or through his/ her authorized Representative having written authorization of the candidate in this regard.

8	Declaration of Final Valid Nominations (after Withdrawal)	11-04-2018 (Upto 5 pm)	Final Lists of Nominations after Withdrawal shall be web published on the Election Portal of the University Website.
9	Date and time of Meeting	17-04-2018 (at 11.30 a.m.)	
10	Time during which the ballot box shall be kept open	17-04-2018 (12.00 noon to 12.30 p.m.)
