Admission of Ph.D. Course for Academic year 2017-18

Online Applications are invited from the eligible candidates for filling number of vacancies of Ph.D. course in the various faculties, those who are qualified CSIR/UGC-NET (JRF, LS), MANF, INSPIRE, RGNF, SET, SLET, GATE, PET-2010, PET-2012, PET-2014, PET-2016 and M. Phil, Five years of approved services as UG/PG teacher or Five years professional / Administrative, Industrial (at Managerial Level) experience, working with recognized organizations can also appear for presentation with consent of research guide and synopsis of appropriate Title to appear for Presentation with consent of Research Guide and synopsis of Appropriate Title. It is hereby directed to all concerned seeking admission to Ph.D. Programme Course for academic year 2017-18 in various subjects those are mentioned in statute – 133 & 228.

The online registration will be available between dated 27/11/2017 to 18/12/2017 and last date of submission of hard copy of application with all relevant documents to Ph.D. Section is up to 30/12/2017. **The last date of submission of hard copy of application to Ph.D. Section is upto 30/12/2017.** Those students who are belonging in reserved category, caste validity certificate should be submitted compulsory within six month from the issuance of provisional registration certificate, if students has not submitted caste validity certificate within stipulated period, the registrations shall be cancelled automatically without any notice informed to candidates.

A qualified & eligible student shall be called for presentation of their synopsis before Research & Recognition Committee with consent of his/her research guide as per procedure laid down in ordinance 167 (B) / 2016 regarding Ph.D. programme. **The total marks of presentation shall be 100 marks.** Registration of candidates for Ph.D. course, allotment of guide, approved the topic of synopsis shall be allotted by Research & Recognition Committee as per merit & the availability of the seats, that is depend on consent of supervisor and acceptance of research proposal as well as reservation policy decided by state & central government from time to time. The number of Guides, number of vacancy and determined reservation i.e. horizontal or vertical reservation shall be mentioned in Annexure 'A'. The University has reserved the right to change the vacancy or number of guide or not to fillup the vacancy & its decision in this regard shall be final. **The application are invited from students subject to State Consumer Court Grievance Redressal forum Aurangabad Bench, Consumer Case No. 95 of 2017 & first appeal No. 572 of 2017. The decision of consumer court in this matter shall be binding to all concerned.**


